

CMPC Giving Statements

With the switch to the CMPC Bridge for managing gifts to CMPC, there are new options for receiving statements and a new look to the statements. Members can select how they want to receive their contribution statements: mail, email, both mail and email, or none at all.

Check Your Statement Delivery Option

Step 1 – Log on to CMPC Bridge

Step 2 – At the top of the screen, select your name, then “My Profile” from the drop-down box.

Step 3 – Select “Edit Profile”

Step 4 – Scroll down to verify that your address and/or email address are correct. If you make changes, remember to click on Save near the top of the screen.

Step 6 – In the Statement Delivery dropdown menu, select your preference for your contribution statement: Email, Mail, Mail & Email, or None. If you make changes, remember to click on Save near the top of the screen.

If you select “None,” you can still generate your own statement at any time from Bridge. To do this, go to your Giving page, select the time period you want covered, click on the printer icon, and select print. Your statement will be generated on the screen where you can elect to print or download it.
